### **PRIVACY NOTICE**

The purpose of this privacy notice ("**Privacy Notice**") is to describe how HELL ENERGY PROMOTION Kft. will process your personal data when you apply for the **Hell Boxing Kings** event ("**HBK**" or "**Event**") it organises and in the assessment of your application. The Privacy Notice helps you to better understand how we use your personal data and explains how we collect it, what we use it for and with whom it is shared.

#### 1. THE DATA CONTROLLER
